**PROHIBITION ORDER**

I, [REDACTED], being an authorised officer of the **Health Service Executive** under the Food Safety Authority of Ireland Act, 1998 (“the Act”), and S. I. No. 117 of 2010, and in exercise of the powers conferred on me by Regulation 20 of S. I No. 117 of 2010, hereby direct that the Bottled Water identified in Part 1 of the Schedule be withdrawn from sale with immediate effect.

I make this order being of the opinion that there is a non-compliance with food legislation as outlined in part 2 of the Schedule and that the food identified in Part 1 of the Schedule should be withdrawn, as directed below

I direct Mr Pdraig McEneaney, Celtic Pure Unlimited to ensure that the food
