





1	4.1.4	Section 9 of SOP A3 requires that the local authority must maintain a dedicated "On Farm Emergency Slaughter" file. At the time of the audit, no dedicated file was maintained by Meath Co. Council.	Since Quarter 1 of 2013, Meath Co. Council has in place a dedicated file for all returns/ correspondence relating to "On Farm Emergency Slaughter".	Quarter 1, 2013			Closed
2	4.2	The current revision of the SOP Emergency Slaughtered Animals is a direct transcription from the Annex 3 Chapter 4 of Regulation 853/2004. It does not describe the actual practices in place in the food business operation to deal with on farm emergency slaughtered animals.	The SOP has been amended to reflect existing practices rather than the previous generic transcription from legislation.	Quarter 1, 2013			Closed

3	4.2	Records were not available to confirm consultation had taken place in all cases between the private veterinary practioner and the temporary veterinary inspector prior to on farm emergency slaughter, as required by Section 7.3 of the local authority veterinary service SOP A.3. In addition, Section 4 of the SOP Emergency Slaughtered Animals states that, prior to emergency slaughter, the food business operator must contact the temporary veterinary inspector in charge. This is not happening in practice.	Private veterinary practioners are now consulting with the temporary veterinary inspector as required by Section 7.3 of the local authority veterinary service SOP A3. In addition, the food business operator is also contacting the temporary veterinary inspector to advise him of the arrival of such animals.	Quarter 1, 2013			Closed

6	4.2	Boxes of meat had a label with the oval identification mark attached to them (which contained a large "E" to indicate that the meat was from an on farm emergency slaughtered animal) rather than a label with a diamond shaped identification mark which is required by legislation.	All meat leaving this food premises which originated from "On Farm Emergency Slaughter" now has a diamond shaped health mark/label as specified in legislative requirements.
